25 year Limited Warranty Certificate

This document is your warranty certificate. Fill in the installation date, model and serial numbers of the tank at the bottom of this document and keep it for your own record.

BASIC WARRANTY:

Superior Tanks Limited. (sometimes hereafter referred to as "Superior Tanks") warrants that its Double Bottom residential steel tanks, equipped with integrated leak detection system (listed with Underwriters' Laboratories of Canada under standard CAN/ULC-S602-07), if exclusively used for the storage of heating oil and if installed and maintain in accordance with CSA B139 in Canada, or applicable requirements of the authority having jurisdiction, and Superior Tanks specified installation instructions:

- 1. Will be free from manufacturer's defect in materials and workmanship under normal and proper use, operation and maintenance for a period of ten (25) years commencing on the date of original purchase or use of the tank by home owner (the "Basic Warranty").
2. During the first twenty five (25) years after installation, Superior Tanks will provide a replacement tank of similar size and configuration if the primary tank becomes perforated as a result of internal corrosion and compensate the purchaser of the double-bottom tank, for property damages incurred by the purchaser, directly caused by leakage from the defective double bottom primary tank, up to a maximum of five million dollars (\$ 5 Million).

Superior Tanks Limited. Liability under its Basic Warranty shall be limited to, at Superior's sole option:

- (a) Delivery of a replacement tank to the point of original delivery, or
(b) Refund an amount equal to the distributor's purchase price from us.
(c) Any labour, material, freight and/or handling charges associated with any repair or replacement to this limited warranty must be accompanied by the supporting documents, be approved by Superior Tanks and limited to one thousand dollars ( \$1,000).

THIS LIMITED WARRANTY EXPRESSLY EXCLUDES:

- (a) Damage caused by any act of God, act of war, vandalism or hostile disturbance; or,
(b) Any damage caused intentionally or through negligence by installers, purchasers or any other third party.
(c) Damage caused by failing to provide proper maintenance to the tank.

THIS LIMITED WARRANTY SHALL BECOME VOID AND TERMINATE SHOULD ANY FLUID OTHER THAN HEATING BE INTRODUCED OR STORED IN THE TANK OR IF ANY ALTERATIONS ARE MADE TO THE TANK, WITHOUT PRIOR WRITTEN APPROVAL OF SUPERIOR TANKS.

In no event will SUPERIOR TANKS, its officers, employees, agents or representatives, be liable to the owner or any third party, whether for breach of warranty or contract, or imposed by statute, in tort, or otherwise, for any damages or for any indirect, special, punitive, incidental or consequential damages including, but not limited to, loss of contents, or loss relating to the quality of the liquid stored in the tank, or loss of profits or revenue, or loss of business, whether or not SUPERIOR TANKS is advised of the possibility of such loss or damage nor will SUPERIOR TANKS, its officers, employees, agents or representatives, be liable to the owner, or any third party or statutory or regulatory body for any liability assumed by the owner or for any damages, losses, penalties or fines arising from non-compliance with any statutory or regulatory authority. Superior Tanks Ltd., expressly disclaims any expressed or implied warranties concerning quality of the tank, merchantability or fitness for any particular purpose whatsoever, whether statutory or otherwise. No oral or written information or advice given by dealers, representatives, agents or employees shall create a warranty or in any way increase the scope of this Warranty.
